## **Description:**

SPRAY BOOTH, MASKANT consisting of:A custom made unit 20 ft by 80 ft by 14 ft. This unit uses airless spray guns actuated by plant air, with water type filtering. The exhaust is 30,000 ACFM driven by a 25 hp electric motor. The water circulation pump is rated 10 hp.

#### **CONDITIONS:**

1. This equipment shall be operated and maintained in strict accordance with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit. [District Rule 204]

2.All coatings, diluents, thinners and solvents, including the cleanup and storage of, shall comply with District Rules 442 - Usage of Solvents, 1115 - Metal Parts and Coating Operations, and 1118 - Aerospace Vehicle Parts and Products Coating Operations, in their entirety.

Additionally, the following activities must comply with 40 CFR 63, Subpart GG, in their entirety. See Appendix A for full requirements of Subpart GG.

- (a) Any cleaning operation,
- (b) Any primer, topcoat, and specialty coatings applications,
- (c) Any depainting application,
- (d) Any chemical milling maskant application operations, and
- (e) Any waste storage and handling operations.

- 3. The owner/operator shall maintain an operations log for this equipment current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and/or Federal personnel, upon request. The log shall include, at a minimum, the information specified below:
- (a) A current list of all VOC -containing coatings and materials used, including the following:
- (i) Material name and manufacturer identification,
- (ii) Application method used,
- (iii) Material category (from District Rule 442, 115, or 1118, as applicable),
- (iv) Specific mixing ratio used,
- (v) Any catalyst, reducer, etc. used,
- (vi) Maximum VOC content as applied,
- (vii) The VOC containing material's manufacturer specification sheets, MSDS/SDS, which lists the current VOC content of each material in use at the facility.
- (viii) The purchase records identifying the type or name and the volume of material purchased for each VOC-containing material
- (b) On a daily basis, the owner/operator must record the following:
- (i) The coating and mix ratio of components used, and
- (ii) The quantity of each coating applied.
- (c) Any repairs, or corrective actions made on this equipment.

- 4.Only High Volume Low Pressure spray equipment shall be used for applying coatings in this booth. [District Rules 1115, 1118 and 40 CFR 63, Subpart GG]
- 5.Emissions from this facility must not exceed the following limits. The owner/operator must demonstrate compliance with these facility-wide emissions limits by calculating and recording, in tons, on a calendar month basis; and, totaling each consecutive twelve-month period.
- (a) 15 tons of PM10
- (b) 25 tons of NOX
- (c) 25 tons of VOC

Emission calculations must be calculated using a District-approved method. The owner/operator shall maintain these calculations (monthly and consecutive twelve-month period totals), current and on-site (or at a central location) for a minimum of five (5) years, and must provide this data to District, State and/or Federal personnel, upon request.

6.The owner/operator must submit a facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
