- 5.An enclosed gun cleaning system must be used.
- 6. Maintain current data on all coatings in use, which includes the following information:
- a. Specific coatings, reducers, catalysts, additives, surface preparation materials and clean up solvents used.
- b. Volume mix ratio of components used.
- c. VOC content of each coating applied.
- 7.Records shall be maintained on a daily basis which include the following information:
- a. Each specific coating material, reducer catalyst, and/or additive applied, and the mix ratio of these components prior to application.
- b. Volume of each coating applied.
- c. Each specific surface preparation and/or clean up solvent used.
- d. Volume of each solvent used.
- e. Total quantity of VOC emitted per day in pounds. The maximum permissible quantity is 250 pounds of non-photochemically reactive VOC emitted per day. Photochemically reactive materials are restricted to a maximum of 39.6 lb/day.
- 8.All records shall be maintained for a period of not less than 24 months. All records shall be disclosed to MDAQMD personnel upon request.
- 9. The equipment shall be operated and maintained in a manner which complies with all applicable rules and regulations of the MDAQMD.
- 10. The o/o shall comply with MDAQMD Rule 1116 in its entirety.
