PAINT SPRAY BOOTH consisting of:Spray King series 200, 14'4" W x 30'4" x 10'9" H, two hp fan rated at 15,000 cfm, with eighteen 20" x 20" x 1" filters.

#### CONDITIONS:

- 1.All coatings used with this equpiment shall comply with applicable District Rules (including Rules 1113, 1114, 1115, 1116 and 442).
- 2.A daily record shall be maintained of the VOC emissions from this facility which contains but is not limited to the following:
- a. Equipment used to apply coating:
- b. Type of coating used, applicable District Rules and VOC limit;
- c. Quantity of coating used and VOC content;
- d. Total VOC emissions if coating covered by Rule 1113, 1114, 1115 or 1116;
- e. If coating is covered by Rule 442:

- (2) Total VOC emissions photochemically reactive;
- f. Total VOC emissions.

This information shall be maintained on site for a minimum of two (2) years and be provided to District personnel on request. (NOTE: The daily log information provides a basis for the Toxic Emission Inventory required by AB2588).

3. The total VOC emissions for this facility (photochemically reactive and non-photochemically reactive) shall not exceed 250 pounds per day.
