1.All coatings, diluents, thinners and solvent shall comply with District Rules 1115 and 442 in their entirety. Rule 1115 pertains to Metal Parts and Products Coating Operations and Rule 442 pertains to Usage of Solvents. (Note: Lacquer thinner is used for glue clean-up.)

- 2.A daily record shall be maintained of the VOC emissions from this facility which contains but is not limited to the following:
- a. Type of coating used, applicable District rule and VOC limit
- b. Quantity of coating used and VOC content
- c. Total VOC emissions if coating covered by Rule 1115
- d. If coating is covered by Rule 442:
- (1) Total VOC emissions not photochemically reactive
- (2) Total VOC emissions photochemically reactive
- e. Total VOC emissions
- 3. This log shall be maintained on site for a minimum of 2 years and be provided to District personnel on request. (NOTE: The daily log information provides a basis for the Toxic Emission Inventory required by AB2588).
- 4.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District,
