Description:

INLAND FLUSHING AND PAINT SPRAY BOOTH consisting of: Building 881. Model 225A, which is designed to be portable, but will remain in building 881. This booth is 66" wide by 38" deep and 90" high. The motor, which drives the fan exhausting the emission through, is 0.5 hp. This unit will be used to paint truck/automobile radiators and other vehicle parts.

CONDITIONS:

1. All coatings, diluents, thinners and solvents shall comply with District Rules 442, 1115 and 1116 in their entirety. These rules pertain to Solvent Use, Metal Parts and Coating Operations and Automotive Refinishing Operations.

2. A daily log shall be maintained of the VOC emissions from this facility which contains at least the following items:

- Equipment used to apply coating.
- Type of coating used and its VOC limit under each of the above applicable Rules.
- Quantity of coating used and its VOC content.
- Total VOC's generated by b. and c. above if covered by the above applicable Rules.

3. This log shall be kept current, on site for a minimum of two (2) years and provided to District personnel on request. (NOTE: The daily log information provides a basis for the Toxic Emission Inventory required by AB 2588.)

4. All equipment used at this facility shall be operated and maintained in strict accord with those recommendations of the manufacturer/supplier.
