- C. Quantity of coating used and its VOC content.
- D. Total VOCs generated by B and C above if covered by the above applicable Rules.

This log shall be kept current, on-site for a minimum of two years and provided to District personnel on request. (NOTE: The daily log information provides a basis for the Toxic Emission Inventory required by AB 2588.)

- 3.Discharge filters shall be installed and maintained in a tightly mounted and dimensionally stable condition free of excessive deposits or interference with air flow passages.
- 4. This equipment shall be installed, operated and maintained in strict accord with those recommendations of the manufacturer, or if manufactured by the applicant, approved by the District APCO.
