CONDITIONS:

1. The o/o shall operate this equipment in compliance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
2. The o/o shall operate and maintain all equipment associated with this permit in strict accord with the recommendations of the manufacturer and sound engineering practices.
3. Coatings shall only be applied using a single, batch-mixed component type spray gun.
4. This equipment shall not be used to apply any coating with a volatile organic compound (VOC) content in excess of 3.5 pounds per gallon (420 grams/liter).
5. Surfaces shall not be cleaned for subsequent coating in this equipment with solvents whose VOC content exceeds 1.67 pounds per gallon (200 grams/liter).

6. No more than 1000 pounds of VOCs (including preparatory and cleaning solvents) shall be used in this equipment during any calendar month.

7. The owner/operator (o/o) shall maintain current and on-site an activity log for two (2) years. This log shall include:

- a. The date and method of application;
- b. The amount and type of coating (including catalyst and reducer), solvent and exempt compound used;
- c. The VOC content of each coating (including catalyst and reducer) and solvent; and
- d. The amount of diluent, surface preparation, clean-up and wash-up solvent used and the VOC content of each.
