#### **Description:**

SPRAY BOOTH, AUTOMOTIVE consisting of:Spray Systems Inc. Spray Booth for the purpose of painting trash containers, Model No.TB-401616-FDT, Serial No. 12862, Outside Dimension: 16 ft. Wide x 40 ft. Long x 16 ft. High, with 40 Exhaust Filters, each 20 in. x 2 in., and 42 Intake Filters, each 20 in. W x 25 in. L x 2 in. thick. One 42" Spray Systems Inc. exhaust fan, 5 HP motor, producing a flow rate of 25,600 cfm at 0.5 inches static pressure. Facility elevation is 3251 feet above sea level.

#### CONDITIONS:

1. This spray booth and associated equipment shall only be operated and maintained in strict accord with manufacturer's/supplier's recommendations and/or sound engineering principles which produce the minimum emissions of contaminants. Operation of this equipment shall be conducted in compliance with data and specifications submitted with the application under which this permit is issued unless otherwise noted below.

2.All Automotive Refinishing Operations, Automotive Coatings (including diluents, thinners, etc.), Solvents, Application Methods, Surface Preparation & Cleaning Operations, and record keeping, shall comply with District Rules 442, 1115, 1303 and 1320 as applicable. These rules pertain to Usage of Solvents, Metal Parts & Products Coating Operations, New Source Review Requirements, and New Source Review for Toxic Air Contaminants, respectively.

3.Exhaust filters shall be installed and maintained in a tightly mounted and dimensionally stable condition, free from excessive deposits or interference with airflow passages. The differential pressure across the exhaust filters shall be maintained within the range specified

- 4.Pursuant to Rule 1115, the owner/operator shall not apply any Coating to Metal Parts and Products unless one of the following methods is used:
- a. Electrostatic Application;
- b. High Volume Low Pressure (HVLP) Spray equipment;
- c. Dip Coating;
- d. Roller Coat;
- e. Airless spray;
- f. Air-assisted airless spray
- g. Hand Application Methods; or,
- h. Other coating application methods as are demonstrated to have a Transfer Efficiency at least equal to or better than achieved by HVLP spraying; or
- i. Equipment as approved by the APCO, CARB and USEPA, provided that the Owner/Operator submits an application and demonstrates that the use of HVLP spray Equipment would result in greater emissions than the proposed system Equipment. The approval shall be limited to only those Coatings listed in the application plan.

- 5.Total VOC emissions from this Prep/Spray Booth shall be less than 25 pounds per day and less than 20 tons per year. To ensure that emissions remain below these limits, the total quantity of coatings, reducers, thinners, activators, sealers, and clean-up solvents (excluding Exempt Compounds) used in this booth shall not exceed 4.0 gallons in any one day.

- 6.The owner/operator (o/o) shall maintain an operatorations log for this equipment, current and on-site, for five (5) years. This log shall be provided to District, State and Federal personnel upon request and shall contain the following information at a minimum:
- a. Amount and type of coating, catalyst and/or solvent used;
- b. VOC content of each coating and other VOC containing material used;
- c. Material Safety Data Sheets;
- d. mix ratio of components used;
- g. Gallons/year of all coatings used which do not comply with the VOC rule limits specified in Rule 1115.

This log shall be maintained on site for a minimum of 2 years and be provided to District personnel on request. [District Rules 1303 and 1520]

- 7.Automotive coating operation is not allowed at this facility. In addition, materials containing PCBTF (p-chlorobenzotrifluoride, CAS 98-56-6) shall not be used at this facility. The facility is required to submit to the District an application to modify the permit, which may require a Health Risk Assessment (HRA) in order to update the operation use and the use of materials containing PCBTF. In addition, public notice and/or a commenting period may be required. [District Rule 1320]
- 8. The daily VOC log shall be kept current, on-site for a minimum of two (2) years, retained for five (5) years, and provided to District personnel upon request. (NOTE: The daily log information provides a basis for the Toxic Emission Inventory required by AB 2588 and Title III requirements)

- 9.Pursuant to 40 CFR 63 subpart HHHHHH, this facility shall not spray apply coatings to metal and plastic surfaces that contain compounds of chromium (Cr), lead (Pb), manganese (Mn), nickel (Ni), or cadmium (Cd); nor, conduct any paint stripping operations on any substrate that use methylene chloride (MeCl)-containing paint stripping formulations. Contact the MDAQMD for conditions if this facility will use coatings containing these compounds and/or MeCl for additional permits requirements.

- 10.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
