STORAGE BIN FEED SYSTEM consisting of:these bins serve the Raymond Mills. The total system capacity is approximately 100 ton. Bin 1-100 760-RP vents to DCL 34 (District permit C000653, which moves 4,700 ACFM) when being filled; Bin 2-100 760-RP vents to DCL 35 (District permit C000651, which moves 4,700 ACFM) when being filled; Bin 3-100 760-RP vents to DCL 36 (District permit C000649, which moves 4,700 ACFM) when being filled; and Bin 4-100 760-RP vents to DCL 37 (District permit C000652, which moves 4,700 ACFM) when being filled. Each bin has a volume of 3300 cu ft, therefore for permit billing purposes, the total volume is 98,736 gallons.

CONDITIONS:

1.Each of the above described bins shall be filled only when vented to the baghouse, under valid District permit, also mentioned above. [District Rule 1302(B)(1)(a)]

2.Unloading and/or emptying each of the above mentioned bins shall only be effected as described on District permit B000647, "100 ton Bin Transfer System".

3.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
