- 1. The owner/operator shall operate this equipment in strict accord with the manufacturer's specification and/or sound engineering principles.
- 2.Operation of this equipment shall be conducted in compliance with data and specifications submitted with the application under which this permit is issued unless otherwise noted below.
- 3. This equipment shall be used for storage only and material stored in these tanks will be transferred, in closed piping, to paint mixing tanks.
- 4. Emissions from this facility shall not exceed:
- a. 12 tons/year of PM10, based on a rolling twelve month basis; and
- b. 1,190 pounds of VOC emissions per month, based on a rolling twelve-month basis; and
- c. 8 tons per year for any single HAP and 20 tons per year for any combination of HAPs, calculated on a rolling twelve-month basis. HAPas defined in Section 112(b) of the Federal Clean Air Act, see http://www.epa.gov/ttn/atw/orig189.html). [District Rules, 1303 Requirements and 1320 NSR for Toxic Air Contaminants]
- 5. The owner/operator of this facility shall maintain an operations log current and on-site for two (2) years, and shall be provided to District personnel upon request. This log shall demonstrate compliance with the VOC limit designated in condition 4, and the HAP limit designated in condition 5, using a District-approved method, with at least the last two years of monthly emissions summaries maintained for a minimum of two years and provided to District, State or Federal personnel upon request.

6.A facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
