# **Description:**

STORAGE TANK, MIXED ACIDS (HF, HCI AND HNO3) consisting of: Tank D-9, which is of cross-linked Polyethylene construction. This tank is 9.9 ft in diameter and 11.5 ft deep with a capacity of 6,500 gallons. This tank is used to hold concentrated hydrofluoric acid (HF), hydrochloric acid (HCI), and nitric acid (HNO3) at ambient temperatures.

#### **CONDITIONS:**

1. This tank shall remain closed except when it is out of service for maintenance and is clean and empty. [District Rules 1303 and 1320]

2. This equipment shall not be operated unless it is vented to the Integrated Dry Scrubber filled w/magnesium oxide as absorbent contained therein (55 gallon drum). The control equipment shall be kept in good operating condition at all times. [District Rules 1303 and 1320]

- 3. The owner/operator shall maintain an operations log for this equipment current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and/or Federal personnel, upon request. The log shall include, at a minimum, the information specified below:
- (a) Daily production of all pump-outs;
- (b) All additions to the tank;
- (c) Amount of metal removed; and,
- (d) All maintenance and repairs made on this equipment.

[District Rule 204 and 40 CFR 70.6 (a)(3)(i)(B) - Periodic Monitoring]

- 4.Emissions from this facility must not exceed the following limits. The owner/operator must demonstrate compliance with these facility-wide emissions limits by calculating and recording, in tons, on a calendar month basis; and, totaling each consecutive twelve-month period.
- (a) 15 tons of PM10
- (b) 25 tons of NOX
- (c) 25 tons of VOC

Emission calculations must be calculated using a District-approved method. The owner/operator shall maintain these calculations (monthly and consecutive twelve-month period totals), current and on-site (or at a central location) for a minimum of five (5) years, and must provide this data to District, State and/or Federal personnel, upon request.

5. The owner/operator must submit a facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
