## **Description:**

FUEL TANK FARM AT BLDG 1577 consisting of:a fuel tank, Number 8, for storage and handling of No. 2 diesel. The tank is 12 ft in diameter and 60 ft long and whose capacity is 50,000 gal. Note: This tank farm consists of 6 of these tanks numbered 6 - 11 (District permits T003308 through T003313) and a circulating fuel pump, which is powered by a 50 hp electric motor.

### **CONDITIONS:**

- 1.The owner/operator, o/o, shall comply with all rules and regulations of this District. Applicable rules include, but are not limited to those in Regulation IV.
- 2.The o/o shall operate and maintain this unit in strict accord with the recommendations of the manufacturer and or sound engineering practices, which produce the minimum emissions of contaminants.
- 3. The o/o shall maintain a log, which contains as a minimum, the daily throughput, volume received and dispensed. This log shall be kept current, on-site for a minimum of 2 years and provided to District personnel on request.
- 4.This tank is limited to the receiving of Number 2 Diesel, whose sulfur concentration is less than 0.05% by weight. Higher sulfur concentrations may currently be present until the dilution of the older supplies, to the 0.05% level is achieved.
- 5.All flanges, seals, pumps and other appurtenant equipment shall be maintained to prevent the loss of volatile fractions.
