#### **Description:**

STORAGE TANK, MIXED ACIDS (HF, HCl AND HNO<sub>3</sub>) consisting of: E-4 Tank, which is cross-linked polyethylene for concentrated acids at ambient temperatures. It is about 10 ft in diameter and 12 ft deep with an operating capacity of 6500 gallons. This tank is used to hold hydrofluoric acid (HF), hydrochloric acid (HCl), and nitric acid (HNO<sub>3</sub>).

#### **CONDITIONS:**

1. This tank shall remain closed except when it is out of service for maintenance and is clean and empty.

2. This equipment shall not be operated unless it is vented to the Integrated Dry Scrubber filled w/magnesium oxide as absorbent contained therein (55 gallon drum). The control equipment shall be kept in good operating condition at all times.

3. The owner/operator shall maintain an operations log for this equipment current and on-site (or at a central location) for a minimum of five (5) years, and this log shall be provided to District, State and/or Federal personnel, upon request. The log shall include, at a minimum, the information specified below:

- (a) Daily production of all pump-outs;
- (b) All additions to the tank; and,
- (c) All maintenance and repairs made on this equipment.

4. Emissions from this facility must not exceed the following limits. The owner/operator must demonstrate compliance with these facility-wide emissions limits by calculating and recording, in tons, on a calendar month basis; and, totaling each consecutive twelve-month period.

- (a) 15 tons of PM10
- (b) 25 tons of NOX
- (c) 25 tons of VOC

Emission calculations must be calculated using a District-approved method. The owner/operator shall maintain these calculations (monthly and consecutive twelve-month period totals), current and on-site (or at a central location) for a minimum of five (5) years, and must provide this data to District, State and/or Federal personnel, upon request.

5. The owner/operator must submit a facility wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
