## **Description:**

SILO-RAW MEAL ES4 consisting of:K3 blending silo, which contains approximately 10,000 short tons of raw meal at 70 lb/cubic ft (total rating 2.56 million gallons). This silo to be designated ES4 will sit approximately 96ft on center from silo ES3. This new silo will be equipped with three baghouses to collect PM-10. Included in this silo will be the necessary rotary control valve motors (electric and air operated); hand operated cut-off gate; airslides and the necessary equipment to tie into K2 Blending Silo, ES3.

### **CONDITIONS:**

- 1.The equipment described above shall not be operated unless vented to air pollution control devices operating under valid District permits, C008473, C008474, and C009753.
- 1.The owner/operator (o/o) shall maintain this equipment in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of air contaminants.
