STORAGE TANK, PORTABLE consisting of:Storage Tank, Asphalt, 30,000 gal; w/ a 3 million Btu/h diesel-fired heater, a 5 hp asphalt circulating pump and is vented to a steel wool packed 55 gal drum. This Storage Tank serves Asphaltic Concrete Batch Plant Permit B011389. Equipment previously permitted as T004005.

#### **CONDITIONS:**

- 1. Operation of this equipment shall be conducted in compliance with all data and specifications submitted with the application under which this permit is issued unless otherwise noted below. [Rule 204]
- 2. This equipment shall be properly maintained and kept in good operating condition at all times. [Rule 204]
- 3. This asphalt storage tank shall not be used unless it is vented to the steel wool-packed drum collector. [Rule 204]
- 4.The heater for this unit shall be limited to using diesel fuel whose sulfur content is equal to or less than 0.0015% by weight. If this unit is to be fired with LPG, no approval by the APCO to use this fuel is necessary. [Rule 204]
- 5. This tank and its associated equipment cannot be operated at the same location for more than 365 consecutive days. This system must be moved within this facility or moved to another facility annually. [Rule 204]
- 6. The electrical requirements of this equipment shall be provided only by line power or equipment permitted by a valid District permit
