2.The owner/operator shall only store F-24 fuel in these tanks. District approval is required prior to changing the type of product to be stored.

- 3. The owner/operator shall maintain an operator's log for each tank, which at a minimum contains the following. Logs must be maintained for at least 2 years and be made available to the District upon request;
- a. Annual throughput, amount received and dispensed,
- b. True vapor pressure of the liquid stored, and
- c. Inspection, repairs and maintenance on equipment.

4. This equipment shall be maintained and operated in accordance with manufacturer/supplier recommendations and/or sound engineering principles.
