#### **Description:**

ODORANT TANK AND INJECTION SYSTEM consisting of:Odorant injection system with 500 gallon above ground odorant tank and related equipment

#### CONDITIONS:

- 1. This equipment shall be installed, operated and maintained in good operating condition and in strict accord with those recommendations of the manufacturer/supplier and/or sound engineering principles which produce the minimum emissions of contaminants. Unless otherwise noted, this equipment shall also be operated in accordance with all data and specifications submitted with the application for this permit.

- 2. The odorant tank and the delivery truck used to fill the odorant tank must be equipped with a Two Point Phase I type vapor recovery system capable of achieving 95% control; this vapor recovery system must be utilized whenever the odorant tank is being filled. [District Rules 402 and 1303]
- 3. This tank shall not be filled to greater than 90% of its maximum capacity (to allow for expansion within tank). [District Rule 402]
- 4.A closed loop system shall be used and maintained to ensure that odorant discharged to the atmosphere is minimized during equipment servicing and maintenance.

- 5.The owner/operator (o/o) shall maintain current and on-site for a minimum of five (5) years an operational/maintenance log. This log shall be provided to District, State or Federal personnel upon request and shall include, at a minimum, the following information (NOTE: The daily log information provides a basis for the Toxic Emission Inventory required by AB 2588.):
- a. Annual (calendar year total) quantity of odorant used (in gallons);
- b. Monthly equipment inspections and maintenance, including descriptions of any deficiencies and corrective action. [District Rule 204]
- 6.A facility-wide Comprehensive Emission Inventory (CEI) for all emitted criteria and toxic air pollutants must be submitted to the District, in a format approved by the District, upon District request.
